



## **Crossfire Premier Financial Aid Form**

Players in Crossfire Premier may qualify for financial assistance to cover registration fees. Crossfire Premier accepts financial aid applications within 30 days of a team's registration being activated at the start of each season. Financial aid applications will not be accepted if received by Crossfire Premier after 30 days from the start of a team's registration. For players who join Crossfire Premier after the start of the season, financial aid applications must be received by Crossfire Premier within 15 business days of their acceptance on a team. Financial aid applications that do not include all of the information requested will not be considered for financial aid, and extensions of time to provide missing information will not be granted. Crossfire Premier evaluates financial aid applications based upon the income and household size parameters below in conjunction with other income, business activity and assets for a player's family. Complete financial aid applications will be considered for financial aid at Crossfire Premier's sole discretion and any financial aid is subject to availability of financial aid funds.

All Crossfire Premier players are required to register using the online registration system and pay a minimum fee equal to 1/11<sup>th</sup> of the total registration fee, along with a \$50.00 volunteer fee, at the time of registration. During the registration process a player will be required to pay the registration fee in full or pay 1/11<sup>th</sup> of the total registration fee and sign up for an automatic recurring monthly payment plan. If a player chooses the payment plan option, then automatic recurring monthly payments will be charged to the debit/credit card set up for the payment plan unless financial aid is granted by Crossfire Premier. If financial aid is granted, then Crossfire Premier will credit the player's account for any payments charged in excess of 1/11<sup>th</sup> of the registration fee. The \$50.00 volunteer fee may be refunded at the end of each season if Crossfire Premier volunteer requirements are satisfied. A player will not be allowed to practice until they complete their online registration and provide a copy of the registration confirmation to their team's coach or team manager.

Financial aid applications can be submitted to Crossfire Premier in person during normal business hours or by mail. The following documents collectively known as the “financial aid application” must be submitted in their entirety to Crossfire Premier for consideration of financial aid up to 10/11<sup>th</sup> of registration fees:

- Crossfire Premier financial aid form.
- Original “Letter of Verification Results” provided by the player’s school confirming the qualification and receipt of free or reduced lunch at time of submission of financial aid application.
- Internal Revenue Service Form 1040 (or Form 1040’s) for the calendar year ended December 31, 2010 who claim participant as a dependent on their tax return (i.e. if married filing separately both parents Form 1040’s must be included, if divorced the parent who claims the participant as a dependent for the calendar year ended December 31, 2010 must be provided), including all W2’s, 1099’s and other documents that support total annual income.
- Internal Revenue Service Form 4506 Request for Copy of Tax Return authorizing Crossfire Premier to obtain copy of Form 1040(s) submitted to the Internal Revenue Service.

For players who do not receive free or reduced lunch, financial aid to cover up to 5/11<sup>th</sup> of registration fees may be available if the player’s family calendar year annual income\* is within the income eligibility guidelines for the calendar year ended December 31, 2010:

The following documents collectively known as the “financial aid application” must be submitted in their entirety to Crossfire Premier for consideration of financial aid up to a maximum 5/11<sup>th</sup> of the registration fees:

- Crossfire Premier financial aid form.
- Internal Revenue Service Form 1040 (or Form 1040’s) for the calendar year ended December 31, 2010 who claim participant as a dependent on their tax return (i.e. if married filing separately both parents Form 1040’s must be included, if divorced the parent who claims the participant as a dependent for the calendar year ended December 31, 2010 must be provided), including all W2’s, 1099’s and other documents that support total annual income.
- Internal Revenue Service Form 4506 Request for Copy of Tax Return authorizing Crossfire Premier to obtain copy of Form 1040(s) submitted to the Internal Revenue Service.

### Uniform Charges

Any financial aid provided for registration fees does not cover and/or include uniform charges. Participants will be responsible to pay all required uniform charges in full.

### Team Fund and Travel Charges

Any financial aid provided for registration fees does not cover and/or include individual team fund or travel charges. Participants will be responsible to pay all team specific and travel charges in full.

Privacy Statement

Players do not have to provide the financial aid application, but if a player does not, Crossfire Premier will not be able to potentially provide financial aid. Crossfire Premier will use the information provided for financial aid purposes only. The information will not be shared with any parties outside of Crossfire Premier.

Non-discrimination Statement

Crossfire Premier does not discriminate on the basis of race, color, religion, national origin, sex, age or disability. Any financial aid offered is at the sole discretion of Crossfire Premier.

Financial Aid Withdrawal and Eligibility Termination

Financial aid will be withdrawn by Crossfire Premier in the event any information provided in a financial aid application is found to be incorrect and players will be removed from Crossfire Premier activities for the current and all future activities. By applying for financial aid players expressly consent and understand that they will be removed from current activities and will not be allowed to participate in any future activities of Crossfire Premier if information provided in a financial aid application is found to be incorrect.
